

## 1. Local Plan Sections – Changes Sought to Text & Policy \*

Cambridgeshire Constabulary and its Blue Light Partners (Cambridgeshire Fire & Rescue Service and the East of England Ambulance Service NHS Trust) are **essential social infrastructure providers**, who require developer funded Infrastructure/ facilities to mitigate and manage the impacts arising on service capacity from planned housing and population growth.

The draft Local Plan should therefore attribute appropriate recognition and a higher profile to the important role played by these bodies - in contributing to the creation of safe, cohesive, strong, healthy, vibrant and resilient new communities.

The changes requested below are made within this context.

Under the subheading 'Uses' Section 4 – add a new criterion e. as follows;

**“e. Provision of a fire & rescue service drop down point & contributions to fire & rescue, police and ambulance facilities funding”**

#### Representation 6 – Policy S/NWC: Eddington (5,550 dwellings/14,850 population) (p.225)

Under the subheading 'Uses' Section 4 – add a new criterion i. as follows;

**“i. Provision of a fire & rescue service drop down point & contributions to fire & rescue, police and ambulance facilities funding”**

#### Representation 7 – Policy S/HHR: land between Huntingdon Road & Histon Road (2,700 dwellings/7,290 population) (p.240)

Representation 14 – Policy S/RSC/BR: Land South of Babraham Road, Sawston (280 dwellings/672 population) (p.360)

Add a new criterion d. as follows;

“d. Contributions to fire & rescue, police and ambulance facilities provision/ funding”

In the strategic priority after ‘education’ add “fire & rescue, police, ambulance”

Add the term “and facilities” after ‘infrastructure’ in relation to each criterion 1-4

Representation 17 – Policy I/ID: Infrastructure and delivery - Supporting Information, para 10.69 (p.700)

After ‘healthcare’ in line 3 add “fire & rescue, police, ambulance”

Representation 18 – Infrastructure reference, para 10.70 (p.701)

After ‘delivery of’ in line 2 add “safe, cohesive, resilient”

Representation 19 – Infrastructure reference, para 10.74 (p.701)

After ‘health’ add “fire & rescue, police and ambulance”
